“Athlete” Nomination Form

*****on or before April 30, 2018 will be accepted.*******

ELIGIBILITY

An “athlete” shall be deemed to be one, living or deceased, who has demonstrated character, sportsmanship and integrity as well as outstanding ability in his/her particular activity, having brought honor to themselves and Moose Jaw and District. Athletes nominated for this category must have been retired from active participation in the sport for which he or she has been nominated for a minimum of three (3) years. The nominee must have been a Moose Jaw native or an individual with substantial connections to Moose Jaw and District or a resident during the period for which the outstanding performance is claimed.

NOMINATION CHECK LIST

- Permanent resident of Moose Jaw and District during the relevant part of his/ her career.
- Developed his/ her skill level to a Provincial, National or International standard while a permanent resident of Moose Jaw and District, but may also have gone elsewhere during their career and achieved greatness.
- List of accomplishments and results at the International level (if applicable).
- List of accomplishments and results at the National level (if applicable).
- List of accomplishments and results at the Provincial level.
- Retired from National or higher level competitions.
- Completed the Nomination Form.
- Additional support materials included i.e.: Newspaper articles, letters of support, copies of certificates, etc.
- Two (2) photocopies of nomination form and support materials included (8.5x11 only).
- Photo of the candidate either recent or during the period of time for which his/her accomplishments took place.

Each nomination will be considered by the Board of Directors. Please be aware that nominations are rarely successful in their first year of submission. Nominations will be retained for three (3) years subject to the discretion of the Board of Directors and nomination guidelines established by the Moose Jaw and District Sports Hall of Fame. Nominators are encouraged to submit updates to the nomination on an annual basis as applicable to the nominee. After three (3) years, a nomination will lapse if not selected. “Builder” Nomination Form

ELIGIBILITY

A “builder” shall be one, living or deceased, whose service, other than that of an athlete, has made an exceptional contribution to a particular sport or sports. The term “builder” illustrates a variety of functions including: coach, official, administrator, volunteer, media and sports medicine whose work for sports over an extended period of time has been outstanding having brought honor to themselves and Moose Jaw and District. The nominee must have been a Moose Jaw native or an individual with substantial connections to Moose Jaw and District or a resident during the period for which the outstanding performance is claimed.

NOMINATION CHECK LIST

- Permanent resident of Moose Jaw and District during the relevant part of his/ her career.
- Developed his/ her skill level to a Provincial, National or International standard while a permanent resident of Moose Jaw and District, but may also have gone elsewhere during their career and achieved greatness.
- He/ she directs athletes in a leadership capacity.
- One of the following: coach, official, administrator, volunteer, media and sports medicine.
- Recognized for his/ her outstanding effort in one or more sports, normally for at least ten (10) years, but not necessarily consecutive.
- List of contributions to amateur sport in Moose Jaw and District.
- Completed the Nomination Form.
- Additional support materials included i.e.: newspaper articles, letters of support, copies of certificates, etc.
- Two (2) photocopies of nomination form and support materials included (8.5x11 only).
- Photo of the candidate either recent or during the period of time for which his/her accomplishments took place.

Each nomination will be considered by the Board of Directors. Please be aware that nominations are rarely successful in their first year of submission. Nominations will be retained for three (3) years subject to the discretion of the Board of Directors and nomination guidelines established by the Moose Jaw and District Sports Hall of Fame. ELIGIBILITY

A “team” shall be deemed to be two or more people, living or deceased, who together have won a Provincial, Regional, National, Olympic or World Championship. Special consideration will be given to local teams who have reached the maximum level of excellence in their field with no competition beyond the District having brought honor to themselves and Moose Jaw and District. Athletes nominated for this category must have been retired from active participation in the sport for which they have been nominated for a minimum of three (3) years. The team must be based in, and comprised of Moose Jaw and District residents during the period for which the outstanding performance is claimed.

NOMINATION CHECK LIST

- Permanent resident of Moose Jaw and District during the relevant part of their career.
- Developed their skill level to a Provincial, National or International standard while a permanent resident of Moose Jaw and District, but may also have gone elsewhere during their career and achieved greatness.
- 75% of the same team members over the period evaluated.
- List of accomplishments and results at the International level (if applicable).
- List of accomplishments and results at the National level (if applicable).
- List of accomplishments and results at the Provincial level.
- Retired from competition.
- Completed the Nomination Form.
- Additional support materials included i.e. newspaper articles, letters of support, copies of certificates, etc.
- Two (2) photocopies of nomination form and support materials included (8.5x11 only).
- Photo of the candidate(s) either recent or during the period of time for which their accomplishments took place.

Each nomination will be considered by the Board of Directors. Please be aware that nominations are rarely successful in their first year of submission. Nominations will be retained for three (3) years subject to the discretion of the Board of Directors and nomination guidelines established by the Moose Jaw and District Sports Hall of Fame.
